**Sub :- Revised Rates of Electricity Duty Notified by the GoM wef Sept. 2016**

**Background :-**

The GoM in exercise of the powers conferred by sub-section g) of section 3 and Schedule A, B and C of the Maharashtra Electricity Duty Act, 201-6 (Mah. XXVI of 2016) and of all other powers enabling it in this behalf, and in supersession of the Government Notification, Industries, Energy and Labour Department, No. ELD. 201b/CR. 2LrNRG. 1, dated the 13th April 2015 the Government of Maharashtra hereby specified with effect from the billing month of September 2016, the rates mentioned in column (3) of the Tables appended here to, to be the rates at which the electricity duty shall be levied and paid in respect of the consumption of energy mentioned in column (2) of the said Tables as mentioned below :-

The rate specified in Table No 'B' for Sr. No. 1 will be applicable for self use consumption through CPP where generation and consumption is at same premises. If any consumer wheels electricity for self use through open access then rate mentioned at Table No. C will be applicable to such cases.

Apart from above the rates to other remaining categories will be charged @ Part A to Part – G under which such category is mentioned in detail under Schedule A of amended Maharashtra Electricity Duty Act. 2016.

As per the GoM Notification the rates will be applicable wef Sept. 2016 Billing month hence as the billing of the Sept 2016 has all ready been done the Electricity Duty for Sept. 2016 will be charged along with bill for October 2016 to all newly introduced categories as there is no change in rate of Elect. Duty to the existing duty chargeable categories.

All field officers are requested to take note of above amendment and ensure the charging of Electricity Duty to consumers as per rates specified in GoM notification as above.
